The Organization coordinates donors and volunteers to build homes for low-income families in the Lake City/Columbia County area under the guidelines of the International Habitat for Humanity. Families are required to provide 'sweat equity' by working on projects at least 350 hours. Family must meet minimum credit standards to qualify for no interest mortgage on the home. Organization uses the mortgage repayment and other donations to build houses for other qualifying families. Homes repossessed for extremely delinquent accounts are renovated for resale and may be rented while a partner family or buyer is located.
